Our school, in cooperation with the Virginia Department of Criminal Justice Services and the Virginia Department of Education, is conducting the Virginia School Survey of Climate and Working Conditions. We will survey students in grades 6, 7, and 8, as well as classroom instructors and staff, in February 2023. The purpose of this survey is to measure student support, student engagement, school discipline, and safety conditions in each school. I am writing to provide you with information about the student survey. The survey will be completed online between February 13 and February 17, 2023. The survey does not ask for your child's name and all answers are anonymous. No one, including teachers or administrators, will know how your child answered the survey. You will not have access to your child's survey answers, even as their parent or guardian. All students in your child's grade level are eligible to participate in the survey. Students participating in remote instruction and in-person instruction are both eligible to participate. The survey is voluntary, and your child can decide not to participate. No action will be taken against you, your child, or the school if your child does not participate.
